On 19 February 2020, nine people in Hanau were cruelly torn from their lives and those of their families and friends. The attack in which they died was not an isolated incident and the perpetrator was not a lone perpetrator. The attack joins a long list of right-wing and racist violence and attacks in Germany.



One year after the attack, we put up a banner and photos of the murdered on the corner of Gröpelinger Heerstraße and Lindenhofstraße. With this action we want to remember the young people who were killed in the attack in Hanau. But remembering also means changing: Therefore, the action is also a call to all to fight against racism and fascism in this society and elsewhere.

Many people live in Gröpelingen who experience racism themselves and would have a lot to say about the issue. We think it is important to talk about it together and to think about what we can do against everyday racism but also the structural racism that is deeply rooted in this society, politics and institutions. At 'Solidarisch in Gröpelingen' has recently been an anti-racist committee. The aim is to make the issue in Gröpelingen more public and to bring people from Gröpelingen together to build up an anti-racist organisation in the district in the long term. ## Solidarisch in Gröpelingen current issues

### Advice on legal issues

The district union of 'Solidarisch in Gröpelingen' starts the year 2021 with a new counselling service:

From now on we offer counselling in social law, labour law, tenancy law and residence law issues. Under the current conditions, the counselling is unfortunately limited and only available by appointment.

When the Corona situation allows it again, we will offer open counselling hours. During the open counselling hours, in addition to counselling on the content, there will also be support in reading, understanding and translating letters. We are also looking for people from the district who would like to be present during the open counselling hours and help with reading, explaining or translating letters. Please feel free to contact us.

#### Why do we do this?

The district union of 'Solidarisch in Gröpelingen' is a political and social district organisation. It is a place in the district where people come together and fight for concrete improvements in their living situation. Nobody gets paid for working at 'Solidarisch in Gröpelingen'. We are financed exclusively by membership fees and the support of neighbours who show solidarity. This is important to us so that we are and remain independent.

The first step to fight for an improvement of our living situation is to learn about our rights and to work on urgent problems. Legal counselling is therefore an important component.

Through legal counselling we can strengthen ourselves, reduce stress and avert existentially threatening situations. But legal counselling alone is not enough in the long run. Often, one also has to negotiate and fight for an improvement in this way. Because many laws are themselves unjust and mainly protect the profit interests of others rather than our basic needs. In labour law, for example, longer and more flexible working hours have been legally enshrined over the years. Tenancy law regularly provides for constantly rising rents and the right of residence contradicts basic human rights in so many places.

Good and professional legal advice is therefore only one leg of the district union. Joint organising, general assemblies and collective action is the other. Because one finger can be broken, but five fingers are a fist.

### Tenants of vonovia in Gröpelingen organize themselves - are you with us?

Recently, the nationwide campaign "voNOvia" was launched, in which individuals, tenants' associations, lawyers and groups like us from different cities are participating. The goal is to jointly prevent vonovia from making profits on operating costs and modernizations.

To implement the nationwide campaign in Gröpelingen, we want to build a strong tenants' committee for 2021.

To do this, we are looking for people who want to be active. We need people who like to plan, organize or feel like approaching and motivating other tenants and neighbors to stand up for a different rent policy. So that at some point housing is no longer a commodity that can be speculated with and simply taken away from people.

### New nationwide tenants' alliance voNO!via hands over open letter to vonovia


On March 01, 2021, the newly founded nationwide tenants' alliance published an open letter to vonovia. In the letter, more than 20 tenant organizations demand, among other things, a nationwide refund of janitor costs and unfounded rent increases due to alleged modernization. The housing committee of Solidarisch in Gröpelingen is also involved. Real estate companies like vonovia make profits at the expense of tenants. ### Resumption of the investigation in the case of Mohamed Idrissi

On June 18, 2020, Mohamed Idrissi was shot dead by police in front of his apartment in Gröpelingen. The investigation into this case was initially closed. As almost always when non-white people and people with mental disabilities are killed by the police. The alliance "Justice for Mohamed", to which Solidarisch in Gröpelingen also belongs, cannot accept this decision. We continued to demand justice for Mohamed and his family, collecting obvious contradictions and emphasizing the incomplete investigation of the police. Mohamed Idrissi's daughter Aicha Meisel-Suhr was leaked a second video showing what happened after the shooting. The video and probing questions about the crime eventually led to the reopening of the investigation in late January 2021.



As reported in the media, the video shows police still handcuffing Mohamed Idrissi, who had already been shot, and then dragging him across the floor, seriously injured. What reasons can there be for dealing with a human being in this way? Was Mohamed Idrissi still alive at this point? Would he have survived if he had been taken care of directly instead of being dragged across the ground with his hands in handcuffs? In what disgusting way will it be explained that this behavior was also appropriate and that the officers only wanted to protect their lives? We are prepared for the worst. Our goal is to continue to break the silence after the murder of Mohamed and to fight for clarification and justice. We continue to fight!
